Pursuant to Article 92 paragraph 4. of Article 93 paragraph (4) and Article 55 of the Constitution of the Republic of Kosovo, pursuant to Article 89 of Law no. 04/L-125 on Health, of Law no. 02/L-109 on Prevention and Fighting Against Infectious Diseases, Article 5 paragraph 2.4 and Article 10 of Law no. 07/L-006 on Prevention and Combating COVID-19 Pandemics in the Territory of the Republic of Kosovo, based on Article 4 of Regulation no. 06/2020 on Areas of Administrative Responsibility of the Office of the Prime Minister and Ministries, as amended and supplemented by Regulation no. 07/2020, in accordance with Article 17 and 19 of the Rules of Procedure of the Government of the Republic of Kosovo No. 09/2011, in order to implement the Decision of the Government of the Republic of Kosovo no. 01/11, dated 15 March 2020 for the declaration of Emergency for Public Health, the Government of the Republic of Kosovo, in the meeting held on 6 November 2020, issued the following:

## D E C I S I O N For protection against the COVID-19 pandemic

- 1. The activity of all business entities and businesses, shopping and recreation centres, supermarkets, entities that provide gastronomy services (restaurants, cases and the like) in the entire territory of the Republic of Kosovo shall be prohibited from 20:00 on: 06.11.2020 (Friday) until 09.11.2020 (Monday) at 05:00, except:
  - 1.1. Bakeries, pharmacies, small markets, gas stations;
  - 1.2. Public and private health institutions for medical needs, production, supply and sale of essential goods;
  - 1.3. Services and activities related to the management of COVID 19 (essential government and municipal management and staff from these sectors health, safety and state administration);
  - 1.4. Economic operators and free transport of goods/services to ensure the functioning of the supply chain.
- 2. Paragraphs 7,8,11,12,13,14,20 of Government Decision No. 01/39 of 01.11.2020 shall be suspended until the time determined according to the enacting clause 1. of this decision.
- 3. The Kosovo Police is obliged to make a rigorous control in the implementation of measures, decisions and Law No. 07/L-006 on Prevention and Combating the Covid-19 Pandemics in the territory of the Republic of Kosovo.
- 4. For all violators of these measures, the competent authorities are obliged to impose punitive measures in accordance with Law No. 07/L-006 on Prevention and Combating the Covid-19 Pandemics in the Territory of the Republic of Kosovo.

5. The decision shall enter into force on the day of its publication in the Official Gazette of the Republic of Kosovo.

## Reasoning

After the imposition of measures by the Government of the Republic of Kosovo on 01.11.2020, with Decision No. 01/39, with a review within two weeks of the epidemiological situation, even this week we have an accelerated increase of positive cases with COVID-19, therefore in order to protect the population from COVID-19 and to avoid the movements of citizens, on the proposal of the Ministry of Health, and in accordance with the recommendations of the NIPHK, it decided as in the enacting clause of this Decision.
