STRATEGIC DOCUMENTS PLAN 2020-2022

The Strategic Documents Plan 2020-2022, as an integral part of the GWP 2020-22, was prepared based on the ministries' proposals for drafting strategic documents for the future planning period. The Office of Strategic Planning (OSP) has evaluated these proposals based on the criteria set out in Administrative Instruction No. 07/2018 on planning and drafting strategic documents and action plans for their implementation.

This list shows the proposal on which strategies should be developed by line ministries, and as such excludes some proposed initiatives, while treats other ones as external documents (obligations) that are not categorized as strategic documents. Consequently, the OSP is working on analysing and evaluating all strategic documents to look at the relevance and duplication they have in between as a result of the large number of strategic documents.

At the end of this analysis and evaluation process, the OSP will bring forward the proposal for the new organization of the local strategic framework starting from the National Development Strategy, cross-sectorial issues and sector strategies, as well as based on a clear definition of sectors to improve the linkage to the Medium Term Expenditure Framework and the Budget.
