1.1 Executive Summary

The National Strategy against Trafficking in Human Beings is a strategic document that establishes policies and measures that should be undertaken against the crime of trafficking in human beings in Kosovo. This strategy and action plan reflects the priorities of the Government of the Republic of Kosovo to combat all forms of trafficking through institutional mechanisms. This Strategy also reflects the commitments of the Government for international cooperation in the field of combating trafficking and the obligations arising from the process of integration of the Republic of Kosovo in the European Union, respectively for the implementation of the obligations arising from the Stabilization and Association Agreement between Kosovo and the European Union.

Strategic and specific objectives have been set following a consultation process with all internal institutional actors in the fight against trafficking in human beings and other external actors such as civil society, academia and international partners. The Strategy is also based on preliminary analyses conducted in collaboration with local and international partners, in particular the US Department of State TIP Report and the GRETA report of 2021, in evaluating the implementing the Strategy, Action Plan 2015-2019, work reports for the National Authority for 2020 - 2021 and the recommendations arising from this evaluation.

This strategic document is divided into two parts: the Anti-Trafficking Strategy and the Action Plan, which contains the strategic objectives, the specific ones as well as the activities which are planned to be met in the three-year period 2022-2024. The strategic and specific objectives, as well as the activities are presented in detail in the Action Plan, which also contains the budget part, measurable and concrete indicators, and describes in detail the responsible institutions and their role in combating trafficking in human beings in Kosovo. Important parts of the Strategy also contain financial impact

calculations which were discussed with the working group and reflected with each relevant institution.

In the National Strategy against Trafficking in Human Beings 2022-2026, concrete actions and measures are recommended in order to address the identified challenges and improve the situation in effectively preventing and combating trafficking. In this regard, actions are envisaged in order to improve the national mechanism, to implement coordinated actions towards prevention and awareness of the consequences of trafficking, to strengthen the system from victim identification to long-term reintegration, to increase efficiency in criminal prosecution of perpetrators of the crime of trafficking in human beings as well as strengthening regional and international cooperation. All these actions are recommended as a result of an assessment of the current situation in the country and in the regional and global context in relation to trafficking, of the results of comprehensive analyses of strategic documents and other empirical analyses derived from various researches conducted during the past years. Consequently, addressing the recommended actions is expected to have a positive impact on addressing the gaps identified in the system, while enabling the advancement and strengthening of prevention and combating of the phenomenon of trafficking.

The action plan is designed in accordance with the strategic objectives, specific objectives and planned activities that will help meet the specific objectives towards achieving the strategic objectives.

1.2 Introduction

Trafficking in human beings is a concerning phenomenon for more than two decades in Kosovo, a phenomenon which has evolved and changed in its forms and trends. Drafting the Strategy and Action Plan against Trafficking in Human Beings 2022-2026 is an obligation deriving from the priorities set by the institutions of the Republic of Kosovo, to prevent and fight organized crime and all forms of its occurrence. As such, National Strategy against Trafficking in Human Beings 2022-2026 has been drafted in accordance with the Government Program 2021-2025,¹as well as in line with the reforms that are being undertaken in the context of the European integration process and other international obligations. The Government program envisages the strengthening of the justice system, focusing on strengthening the rule of law, and consequently on combating trafficking in human beings, as one of the basic principles for the protection of the rights and freedoms of citizens, guaranteed by the Constitution and international conventions. Another priority within the government program is to strengthen cooperation with neighbouring countries and beyond, as well as with international law enforcement mechanisms, in order to align the actions and ensure a coordinated approach in addressing the problem of trafficking in human beings, as well as strengthening its role as a contributor to international peace, security and development.²

The institutions of the Republic of Kosovo address the phenomenon of trafficking in human beings with great seriousness and commitment, creating stable structures, legal basis and effective policies for preventing and combating trafficking in human beings, as well as providing services for the protection and rehabilitation of victims of trafficking.

Despite all achievements, this National Strategy among others envisages that actions against trafficking will continue to be further strengthened.

Kosovo has developed a sound legal and strategic framework for combating trafficking, including institutional mechanisms mandated to coordinate and implement antitrafficking policies. Furthermore, the approximation of legislation with EU legislation continues in line with the National Program for the Implementation of the Stabilization and Association Agreement with the European Union.

The strategy is based on the Law on preventing and combating trafficking in human beings and protecting victims of trafficking, which addresses all forms of trafficking in human beings, both national and transnational, including offenses committed for the purpose of exploitation of victims, while they contain elements of trafficking in human beings.

Given that the phenomenon of trafficking has also affected other countries, where the movement of victims can be done from one country to another, it can be seen that international cooperation is of particular importance, especially the sharing e of experiences and information between countries.

1.3 Methodology

The drafting of the National Strategy against Trafficking in Human Beings 2022-2026 was preceded by a comprehensive evaluation of the implementation of the Strategy and Action Plan 2015-2019, as well as the working reports of the National Authority for 2020-2021. Likewise, the reports of all relevant international mechanisms were analysed in details including those of the U.S. Department of State, the European Commission, the OSCE, the civil society, etc.

The process of drafting of the strategy is coordinated by the National Anti-Trafficking Coordinator. The National Authority, international partners, civil society and other

stakeholders are involved in the comprehensive and detailed evaluation of the implementation of the anti-trafficking strategy 2015-2019. The working group has been working on the analyses of the current situation, identification of challenges that need to be addressed with this strategy and proposing the objectives and measures that will improve the efficiency and effectiveness of the institutions involved in the implementation, with the aim of preventing and combating trafficking in human beings, always being aware of the transnational aspect that this phenomenon entails. The current strategy is also based on the draft of the government working group during 2020-2021, however, due to the situation with the Covid-19 pandemic in Kosovo this version is now updated and re-drafted, reflecting the current challenges deriving from the situation analysis, and based on government priorities for 2022-2026.

The methodology followed in this process includes the evaluation of the implementation of the previous strategy 2015-2019 and the degree of fulfilment of its objectives through the implementation of activities. The evaluation of the implementation of this strategy is in annex 2. After the evaluation of the implementation of the strategy, gaps were identified in fulfilment of previous activities and new activities leading to overall improvement in the field of preventing and combating trafficking were identified. During the workshops and meetings, the current situation was discussed and evaluated, whereby case activities that would help achieve specific objectives and implement strategic ones by proposing improvements focused on preventing and combating trafficking in general were proposed. The approach has been multi-disciplinary, proactive and in working groups with institutional actors, with active participation of the civil society in addressing the needs of victims of human trafficking as well as the key international partners, guaranteeing the ownership process of this strategic document.

Strategic objectives, specific objectives and activities are set out based on data, on findings and recommendations from the process of evaluation of the previous Strategy, on the reports of local and international actors, but also on identified priorities which are in line with the priorities of the Government, as well as on the current situation in Kosovo in the field of combating trafficking. The drafting of the strategy has gone through an interministerial consultation process, as well as through public consultations. When defining strategic objectives, special attention has been paid to avoiding possible duplication of activities and linking this strategy to other national and sectoral strategies approved by the Government of the Republic of Kosovo.

1.4 Background

Trafficking in human beings is one of the most serious violations of human rights, which is often associated with organized crime. Human dignity is ranked as one of the basic human values in the highest legal act, the Constitution of the Republic of Kosovo. Therefore, the institutions of the Republic of Kosovo are committed to take all necessary positive measures to effectively guarantee this value, and in addition to provide protection from the negative phenomenon of human trafficking and at the same time to protect and promote the human rights for all victims of trafficking, regardless of race, nationality or gender.

Trafficking in human beings constitutes a serious crime which often has implications which the countries cannot address individually. Consequently, trafficking in human beings turns out to be a complex transnational phenomenon which has its roots in vulnerability to poverty, lack of democratic culture, gender inequality and violence against women, conflicts and post-conflict situations, lack of social integration, lack of employment opportunities, lack of access to education, in child labour and gender discrimination.

Kosovo used to be mainly a country of destination, including the cases of transit and origin. Whereas now, Kosovo remains mainly country of origin (victims from Kosovo exploited in Kosovo) with fewer cases of destination and transit. Children remain most affected by human trafficking and the most common form of exploitation is sexual exploitation.

Among other achievements reported during 2019-2021 is the continuation of coordination of activities by the National Authority and the National Coordinator, the work of the Directorate for Investigation of Trafficking in Human Beings (DITHB) DITHB as a specialized directorate in the prevention and investigation of trafficking, the appointment of coordinators in seven basic prosecution offices and initiating the creation of "task forces" at regional levels led by coordinator prosecutors.

Despite the results achieved, some challenges remain, which require increased attention and immediate institutional response, such as strengthening inter-institutional coordination, coordinated activities in prevention, defence and reintegration, as well as increasing the efficiency of investigation and trying of traffickers and the imposing of adequate sentences. International cooperation and non-membership in international security mechanisms remain a challenge per se.

Summary of key activities

Main activities of the Strategy against Trafficking in Human Beings 2022-2026 will focus on supporting victims in a structured and sustainable way with concrete activities in strengthening mechanisms for combating trafficking in human beings, preventing human trafficking, improving the identification, protection and reintegration of victims and presumed victims of trafficking, investigating, prosecuting and punishing cases of trafficking in human beings, and strengthening regional and international cooperation.

For all activities foreseen in this Strategy, a cost and budget line have been determined for the financial coverage of these activities. Some of the activities will be supported by international donors supporting the fight against trafficking in human beings.

1.5 Objectives:

Based on the preliminary analysis of the current situation and recommendations regarding the implementation of the Strategy and Action Plan against trafficking 2015-2019, the working group for drafting the Strategy, has set the following strategic objectives:

<u>Strategic Objective I</u> :	Strengthening institutional mechanisms for combating trafficking in human beings (THB);
<u>Strategic Objective II</u> :	Preventing the phenomenon of trafficking in human beings;
Strategic Objective III:	Improving the identification, protection and reintegration of victims and the presumed victims of trafficking;
Strategic objective IV:	Investigation, prosecution and punishment of cases of trafficking in human beings;
Strategic Objective V:	Strengthening regional and international cooperation.

Strengthening institutional mechanisms for combating trafficking in human beings (THB)

Under this strategic objective, specific objectives are foreseen that will help achieve this objective:

Indicator: Number of relevant actors with increased capacity in reporting and coordination as well as increasing the effectiveness of reporting.

Outcome: Effective coordination and reporting for the provision of quality and sustainable services.

1.6 Monitoring, reporting and evaluating the implementation of the strategy and action plan

The Ministry of Internal Affairs will be the main bearer of the implementation of the Strategy against Trafficking in Human Beings, assisted by supporting institutions. In order to monitor the implementation of the activities foreseen in the Strategy Action Plan, the Secretariat for Strategies within the MIA will be engaged³, which will prepare the following:

• 6-month reports on the achievement of strategic objectives and the

implementation of the action plan. The 6-month report will contain information on achieving the objectives and implementing the activities. In the framework of the 6-month report, in particular, the difficulties encountered, challenges, identified risks and their addressing for the implementation of the strategy will be highlighted;

• Annual reports on the achievement of strategic objectives and the implementation of the action plan. The annual progress report will contain information on achieving the objectives and implementing the activities. In the framework of the annual report, in particular, the difficulties encountered, challenges, identified risks and their addressing for the implementation of the strategy will be underlined, as well as the monitoring of measurement indicators and their implementation.

Institutions responsible for implementation will provide information on the progress of the implementation of the strategy.

The annual plan will be reviewed according to the degree of implementation/nonimplementation of the activities foreseen in the strategy.

The Ministry of Internal Affairs is responsible for coordinating and monitoring the implementation of the National Strategy against Trafficking in Human Beings 2022-2026 and for taking action, if necessary, to ensure the timely and effective implementation of the activities set out in the Action Plan.

The authority responsible for preparing reports according to the mandate is the Secretariat for Monitoring and Evaluation of National Strategies supported by the National Coordinator against Trafficking in Human Beings within the MIA.
