Pursuant to Article 93 (4) of the Constitution of the Republic of Kosovo, Article 10, paragraph 7 of Law No. 05/L-010 on the Kosovo Property Comparison and Verification Agency, amended and supplemented by Law No. 08/L-052, Article 8, paragraph 4, subparagraph 4. 5 of Law No. 08/L-117 on Government of the Republic of Kosovo, and in accordance with Article 19(6.2) of the Regulation No. 09/2011 on Rules of Procedure of the Government (Official Gazette No.15, 12 September 2011).

### **REGULATION (GRK) N0.20/2023 ON AMENDING AND SUPPLEMENTING THE REGULATION (GRK) NO. 08/2017 ON DUTIES, RESPONSIBILITIES AND PROCEDURES OF THE KOSOVO PROPERTY COMPARISON AND VERIFICATION AGENCY COMMITTEES**

#### **Article 1 Purpose**

This Regulation aims to amend and supplement the Regulation (GRK) No. 08/2017 on Duties, Responsibilities and Procedures of the Agency Committees.

#### **Article 2**

1. A new Paragraph 6A shall be added to Article 11 of the basic regulation with the following text:  
6A. The PCC shall decide on the legal recognition of informal property rights according to the conditions and criteria defined by this Regulation and Law No. 08/L-052 on amending and supplementing Law No. 05/L0-010 on the KPCVA.

6.1 The PCC shall decide on informal rights, with a decision on:

6.1.1 recognition of the informal property right and order the registration of the property in the registry of immovable property rights;

6.1.2 rejection or dismissal of requests for recognition of informal property rights.

#### **Article 3 Entry into force**

This Regulation shall enter into force seven (7) days after being signed by the Prime Minister of the Republic of Kosovo.
