ADMINISTRATIVE INSTRUCTION (GRK) NO.04/2024 ON FEE SCHEDULE FOR CADASTRAL AND SURVEYING PRODUCTS AND PROPERTY REGISTRATION SERVICES¹

¹ Administrative Instruction (GRK) 04/2024 on fee Schedule for Cadastral And Surveying Products And Property Registration Services, has been approved in the 211-th Meeting of the Government of the Republic of Kosovo, with the Decision No. 02/211, dated 28.06.2024.

Government of Republic of Kosovo,

Based on Article 93, paragraph 4 of the Constitution of the Republic of Kosovo, Article 12, paragraph 2 of Law No. 08/L-237 on Cadastre of Immovable Property (Official Gazette of the Republic of Kosovo No. 2/09 January 2024), Articles 8 and 11, paragraph 1, subparagraph 1.3 of Law No. 08/L-117 on the Government of the Republic of Kosovo (Official Gazette, No. 34/22 dated 18.11.2022), as well as Article 78(6.2) of the Rules of Procedures of Government No. 17/2024 (Official Gazette 21.06.2024),

ADMINISTRATIVE INSTRUCTION (GRK) NO. 04/2024 ON FEE SCHEDULE FOR CA-DASTRAL AND SURVEYING PRODUCTS AND PROPERTY REGISTRATION SER-VICES

Article 1 Purpose

This Administrative Instruction defines the fees applicable to cadastral and surveying products and registration services pertaining to immovable property rights.

Article 2 Scope

The provisions outlined in this Administrative Instruction shall be applicable to the Kosovo Cadastral Agency, Municipal Cadastral Offices, and applicants engaging with the aforementioned products and services.

Article 3 Definitions

1. For the purpose of this Administrative Instruction, the following terms shall hold the specified meanings:

1.1. **Orthophoto -** A product derived from aerial photography capturing the territory of the Republic of Kosovo.

1.2.**Aerial photo** - Photographs obtained from aerial surveys capturing the territory of the Republic of Kosovo.

1.3. **Topographic map** - A cartographic depiction illustrating the relief of the Republic of Kosovo's territory.

1.4. **DTM** - Digital Terrain Model;

1.5. **DSM** - Digital Surface Model;

1.6. KCLIS - Kosovo Cadaster Land Information System;

1.7. **Municipality boundary** - The administrative borders delineating cadastral areas within a municipality, either bordering neighboring municipalities or coinciding with the state administrative boundaries of the Republic of Kosovo.

1.8. Web Applications - Utilization of online service provision applications.

1.9. Web Services - Digital communication channels with KCA systems.

2. Any other terminologies employed within this Administrative Instruction shall carry the same definitions as stipulated in Law No. 08/L-237 on Cadaster of Immovable Property.

3. In the context of this Administrative Instruction, masculine pronouns encompass feminine forms and vice versa, without discrimination.

Article 4

Products of the Kosovo Cadastral Agency

1. KCA products are assets owned by the Government of the Republic of Kosovo and are under the jurisdiction and authority of the KCA.

2. KCA products comprise data generated through aerial surveys and official measurements conducted in accordance with Article 10 paragraph 3, subparagraph 4, and Article 26 of Law No. 08/L-237 on Cadaster of Immovable Property, as specified in Appendix 1 of this Administrative Instruction.

3. The KCA Executive Director shall, by decision, determine the list of products and services to be offered by KCA.

Article 5 KCA Services

KCA services encompass cadastral and cartographic data, coordinate system transformations, KOPOS positioning system services, and other services as prescribed by prevailing legislation, detailed in Appendix 1 of this Administrative Instruction. Additionally, services include registration of immovable property rights and those outlined in Appendices 2, 3, and 4 of this Administrative Instruction.

Article 6 Fees for Specific Products and Services

Fees for specialized products and services, not integral to routine cadastral activities or not explicitly outlined in this Administrative Instruction, shall be proposed by MESPI and determined by government decision.

Article 7 Payment for Products and Services

1. Payments for KCA products and services adhere to the relevant legislation on Public Finance Management and Responsibilities.

2. Payment for KCA products and services is made according to the rates specified in the Appendices of this Administrative Instruction.

3. Payments for KCA products and services are conducted in Euros (\in).

Article 8 Exemption from Payment of Fees

1. All Kosovan students and those from other countries engaged in preparing seminars and diploma theses, with certification issued by their respective faculties, are exempt from fees for requested products up to one hundred euros ($\in 100$) within an academic year.

2. In cases where master's and doctoral student requests exceed the limit stated in paragraph 1 of this article, the Executive Director of KCA shall make the determination.

3. The following groups shall be exempted from the payment of registration fees, from all points within Annex 2, including the Fees for Registration Services for Immovable Property:

3.1. Single mothers;

3.2 Persons receiving social assistance, namely women receiving social assistance;

- 3.3 Persons with disabilities;
- 3.4 Victims of domestic violence;
- 3.5. Survivors of sexual violence during wartime.

4. Individuals from paragraph 3 must present evidence from the organization they belong to.

5. Individual buildings constructed by the Municipality or Government through humanitarian aid programs shall be exempted from the registration fee are.

6. All individuals for whom exemption from fees is provided for by the relevant applicable legislation shall be eempted from the payment of fees from Annex 2, Annex 2, including the Fees for Registration Services for Immovable Property.

Article 9 Use of KCA Products

1. KCA is not authorized to transfer ownership of released products to third parties. However, such parties are granted the right to utilize these products within the framework and conditions stipulated for their use.

2. The right to use KCA products may be revoked if parties fail to utilize the products as per the agreed terms.

Article 10 Products via Web Applications and Web Services

1. KCA provides services and products via web applications and web services to all stakeholders.

2. The provision of services and products shall be established through mutual agreement with each party.

3. Fees for services and products shall be paid in accordance with the appendices of this Administrative Instruction.

Article 11 Complaints Regarding KCA Products and Services

Parties aggrieved by the products, services, or procedures of receipt from KCA may lodge a complaint with the KCA Complaints Commission within thirty (30) days.

Article 12 Fee Determination Methodology

The fees assigned to products and services as delineated in this Administrative Instruction are reflective of the costs and time involved in executing cadastral services.

Article 13 Appendices

1. The integral components of this Administrative Instruction comprise:

1.1. Appendix 1: Fee schedule for products and services provided to natural and legal persons and to Public Institutions of the Republic of Kosovo.

1.2. Appendix 2: Fee schedule for immovable property rights registration services.

1.3. Appendix 3: Fee schedule for information and records from the Kosovo Cadastral and Land Information System.

1.4. Appendix 4: Fee schedule for other services.

Article 14 Repeal

Upon the enforcement of this Administrative Instruction, the following shall be repealed:
Administrative Instruction MESP No. 08/2019 on Tariffs of Products and Services of the Kosovo Cadastral Agency.

Article 15 Entry into force

This Administrative Instruction shall enter into force seven (7) days after its publication in the Official Gazette of the Republic of Kosovo.
