## **ADMINISTRATIVE INSTRUCTION (GRK) - No. 06/2024 FOR AMENDING AND SUPPLEMENTING THE ADMINISTRATIVE INSTRUCTION (GRK) No. 13/2022 ON THE MANNER AND PROCEDURE OF THE SALE AND LEASE OF SEQUESTERED AND CONFISCATED MOVABLE AND IMMOVABLE ASSETS**

### **Article 1 Purpose**

The purpose of this Administrative Instruction is to supplement and amend Administrative Instruction (GRK) - No. 13/2022 on the Method and Procedures for the sale and leasing of Seized and Confiscated Movable and Immovable property, (hereinafter: Basic instruction).

### **Article 2**

Following Article 21 of the Basic instruction, a new Article 21/A is added as follows:

### **Article 21/A**

1. The agency may lease the movable and immovable assets without a public auction during the sequestration phase if such assets are requested by a state body or public institution.
2. The monthly rental price is determined by the Agency.
3. The Agency may at any time during the sequestration phase return the movable and immovable assets if public interest requires it.
4. The public body or institution is obliged to administer and manage the movable and immovable assets during the sequestration phase, including preserving their value according to the lease contract.
5. For any damage to sequestered assets, the public institution or state body in the capacity of lessee is responsible for compensation.

**Article 3**  
**Entry into force**

This Administrative Instruction enters into force seven (7) days after its publication in the Official Gazette of the Republic of Kosovo.
