Introduction

The Programme for the Prevention and Reduction of Administrative Burden 2022–2027 and the Action Plan 2022–2024 (hereinafter referred to as the Programme) was approved by the Government of the Republic of Kosovo (hereinafter referred to as the Government) on 14 September 2022. Under the supervision of the First Deputy Prime Minister and the leadership and coordination of the Strategic Planning Office (hereinafter SPO) within the Office of the Prime Minister (hereinafter OPM), all strategic and specific objectives outlined in the action plan for the implementation of the Programme have marked advanced progress, as also highlighted in international reports.

Given that the Programme was designed as a flexible document that evolves through and because of the process, a number of activities—although not specifically highlighted in the Action Plan (hereinafter AP)—have been supported and implemented within the framework of the Programme, as they are related to the activities outlined in the Plan and align with the Programme’s overall approach

Furthermore, the achievement of the results presented in the Report was primarily made possible through strong political support and the prioritisation of the process by the First Deputy Prime Minister and his Cabinet, effective support, cooperation and communication from the line Ministries and relevant agencies, the collaboration and advocacy of civil society organisations and business chambers, as well as the significant support of development partners.

Some of the main international assessments from these two years of implementation are as follows:

- *The 2024 Country Report highlights the implementation of the Programme as advanced progress and one of the main achievements in the field of public administration, stating that “Kosovo has advanced in reducing the administrative burden through the simplification of procedures via the implementation of the 2022–2024 Programme”.¹*
- *The 2024 OECD/SIGMA Monitoring Report assessed the Administrative Burden (ABR) process, emphasising that “the policy on administrative simplification, reduction, and prevention of administrative burden has made considerable progress”. For this, two key indicators for ABR were rated at 100%, specifically indicator 19.4 for Administrative Burden Reduction, where 15 out of 15 points were achieved (100%), and indicator 6.1 for the Implementation of Administrative Simplification Measures, where 20 out of 20 points were achieved (100%). It should be noted that the 2021 report had rated this process with only 0.6 out of 6 points in total.²*

Some of the main achievements during these two years of implementation are as follows:

- *Established sustainability of the process, involving over 60 officials working on administrative burden on a weekly basis;*
- *Trained 500 officials at both central and local levels;*
- *Simplified 115 services at the central level;*
- *Simplified over 600 services at the local level across 22 municipalities;*
- *Analysed more than 200 central-level services ready for simplification;*

- *Digitised and initiated digitisation of over 100 central-level services;*
- *Saved over €3.5 million for citizens and businesses following the simplifications.*

The achievements highlighted in this report would be incomplete without the support of the European Union and Germany through the co-financed project for reducing the administrative burden, as part of the 'Support for Reforms for European Integration in Kosovo' module, implemented by GIZ, as well as without the support of the Swiss Government's State Secretariat for Economic Affairs (SECO) through the 'Accelerating the Investment Climate' project, implemented by the International Finance Corporation (IFC).

Interested parties may request all evidence of the achievements presented in this Report from the Strategic Planning Office within the Office of the Prime Minister.

Strategic Approach and Sustainability

The implementation of the Programme for 2022–2023 has been accompanied by key aspects that are essential for achieving results in its execution.

The organisation of work according to these inseparable aspects, which simultaneously create synergy, has contributed to raising the awareness of public officials, civil society, and business chambers about the importance and care that must be given to the administrative burden affecting citizens and businesses. Furthermore, this approach has complemented other digitalisation processes aimed at improving services, as outlined in the Public Administration Reform Strategy and the e-Government Strategy, both approved by the Government. Based on the analysis of the current situation in this field, focusing on the framework for public policy development (strategies, concept documents, and legislation), human resources (policy-making, legal, technological), and the administrative culture of the public administration in the country, the strategic approach for the implementation of the Programme has been developed in a way that adapts to this analysed situation.

Some of the key aspects of this approach (which are outlined in the Programme, although some have also been developed during the implementation process) are as follows:

Planning and ownership of the process

For successful implementation of the Programme, planning and coordination have been centralised, while ownership and execution have been decentralised. In this way, ministries have received ready-made plans and expert support from the centre (from the initial idea through support for drafting or amending policies and legislation, to the development and maintenance of systems over a two-year period), while leading and owning the reform process by designing services in a manner that enables the reduction of burden for citizens and businesses, as well as the reduction of service delivery costs for the respective institutions.

Simplification and digitalization in parallel

The new strategic approach has been developed so that simplification and digitalisation occur simultaneously. It should be noted that, according to the practices of other countries, simplification usually precedes digitalisation. However, the Programme's new strategic approach has taken the path of simplification and digitalisation at the same time, promoting digitalisation as a motivator for simplification. This approach stems from the current state of public administration, which is characterised by delays in legislative changes and an outdated administrative culture.

Combining of topics and officials

Taking into account the administrative culture of the public administration, which is often isolated in the training of various processes that lead to a single outcome (services for citizens and businesses), the new strategic approach has also been developed towards combining topics and public officials on the same issue. In this regard, working groups, trainings, forums, and various events have been organised so that policy-makers, legal officers, and information technology officials come together, both for training on the administrative burden process and throughout the process for discussion and implementation of activities aimed at achieving the same results.

Collaboration: from advocacy to implementation

Typically, in other countries, some of the analyses, measurements, or identification of methodologies and ideas are conducted through collaboration between the government and universities. Given the lack of capacities in the public administration for certain important aspects of the Programme's implementation—such as analyses, measurements, and the identification of methodologies and best practices—the new approach has also included collaboration for implementation with civil society organisations and business chambers to advance the process from advocacy cooperation to implementation cooperation. In this context, some of the analyses, measurements, or monitoring activities under the Programme have been carried out with the support of civil society organisations or business chambers.

Awareness raising within administration

Raising awareness of the administrative burden within the administration is one of the most important aspects of the Programme's approach. This is being achieved through training, joint design and work, working groups, and joint forums. As noted above and as will be detailed further in the Report, the new training module has proven to also serve as a means to raise awareness about the administrative burden process and the benefits for officials in preventing or reducing burdens and digitalising processes. Additionally, one method to foster awareness is the joint design process of services or creative thinking, where officials, grouped by different profiles, learn, discuss, and create service prototypes centred around the user, designing them in a way that facilitates their work throughout the process.

One of the key aspects for the implementation of the Programme is ensuring sustainability. This aspect is necessary and crucial for impacting the administrative culture in the development and design of public policies (strategies, concept documents, and legislation) aimed at improving the delivery of services for citizens and businesses, with the goal of preventing and reducing the administrative burden.

In the context of ensuring sustainability for the implementation of the Programme, measures have been taken in four directions: mechanisms, tools, analyses, and trainings.

The establishment or operationalisation of mechanisms for the implementation of the Programme has focused on two levels: political and operational (central and local). Regarding the political level, as highlighted in the Programme, the Strategic Planning Commission (hereinafter SPC), chaired by the Prime Minister, has convened twice a year. Within this commission, the First Deputy Prime Minister was responsible as the political lead for the administrative burden process, while the SPC members included the relevant ministers whose attention was necessary to advance the Programme's implementation. Additionally, the SPC comprises an operational secretariat covered by the Strategic Planning Office within the Office of the Prime Minister. At the operational level, the establishment of mechanisms has focused on three levels: the Office of the Prime Minister, central institutions, and municipalities, where the following has been carried out:

1. *Appointment of the Administrative Burden Process Coordinator by Government decision*
2. *Appointment of 20 responsible officials at the central level for the administrative burden process by decision of the Secretaries-General*
3. *Appointment of 32 responsible officials at the local level for the administrative burden process by decision of the Mayors*
4. *Organisation of 3 meetings of the Strategic Planning Commission*

The development, drafting, or improvement of tools, analyses, methodologies, and various plans that have made the implementation of the Programme possible, which enabled its execution, are:

1. *Analysis for updating the guideline on the development of explanatory memoranda*
2. *Drafting of a new guideline for preparing explanatory memoranda*
3. *Development of the methodology for applying the principle of personalisation in the simplification and digitalisation of services*
4. *Development of the guideline for the Standard Cost Model, Cost Coverage, and Excel Templates*
5. *Electronic development of Excel Templates for the Standard Cost Model and Cost Coverage*
6. *Development of the screening test for public policies*

Training of public officials at the central and local levels began in September 2023, following the development of a new module, accompanying materials, and assessment tests in cooperation with the Kosovo Institute for Public Administration (hereinafter KIPA). As briefly highlighted above, the new module follows a combined approach, covering the main components for preventing and reducing administrative burden: the Standard Cost Model (hereinafter SCM), regulatory impact assessment (concept documents), principles of general administrative procedures closely linked to administrative burden, legal drafting, and creative service design—a new concept initiated in public administration. These components are accompanied by conceptual parts such as the definition of administrative burden and digitalisation in the service of administrative burden, as well as public policy development enabling digitalisation. The activities completed to raise awareness among public officials through training are as follows:

1. *Detailed analysis of the trainings offered at KIPA in the context of administrative burden and identification of training needs and profiles for administrative burden*
2. *Preparation of profiles and lists of officials to participate in training sessions*
3. *Preparation of training materials, including manuals, presentations, exercises, and training tests, according to the Programme*
4. *Organisation of training sessions for public officials at central and local levels*
5. *Preparation of the concept for ICT training in gender-responsive policymaking*
6. *Development of the training module for ICT in gender-responsive policymaking*
7. *Preparation of materials, tests, and examples for online training via the Moodle platform*
8. *Organisation of DigiCamp 2023, DigiCamp 2024, and DigiCamp 2025, with over 1,000 participants*

Participation in training has been and continues to be combined, meaning that officials with different functions attend the same training sessions simultaneously, where they share challenges, problems, questions, lessons, and experiences among themselves. This combined approach has proven to motivate interactivity, making the training useful for creating institutional sustainability aimed at preventing and reducing administrative burden. Among other benefits, this approach also serves to raise awareness among public officials about the administrative burden process. Trainings have been organised according to institutional prioritisation, with no more than two sessions per month and a minimum duration of five days per training. The training has been accompanied by knowledge tests at the beginning and end to assess its impact. Data on trainings for 2022–2024 is presented in the following table:

Prevention

Ensuring sustainability is a key aspect in preventing administrative burden in public policies, whether they are concept documents, laws, or subordinate acts. Sustainability in the process motivates systematic work towards achieving the desired reform. In this context, the Government, through the Strategic Planning Office of the Office of the Prime Minister, has undertaken and repeated several measures and activities for the prevention of administrative burden, which will be detailed below:

Development of a checklist in the context of preventing and reducing administrative burden during the preparation of concept documents;

1. *Continuous review of concept documents in the context of administrative burden;*
2. *Continuous review of legislation in the context of administrative burden;*
3. *Identification of key permits most frequently obtained by women and young people;*
4. *Development of the business information passport.*

Concept Documents³

It should be emphasised that prevention has been applied at two levels: in concept documents and in legislative and sub-legislative acts. Regarding the review of concept documents prior to their approval by the Government, the following results have been achieved:

Legislation

It should be emphasised that the review of all legislative and sub-legislative acts during the 2023–2024 period was categorised into relevant and non-relevant for administrative burden. This categorisation was made based on several criteria, as follows:

1. *Relevant are all legislative or sub-legislative acts that include services or regulate their provision for citizens and businesses, such as licences, permits, registrations, approvals, authorisations, certifications, etc., as well as when the service itself is regulated—such as reception, organisation, maintenance, division of responsibilities, procedure design, establishment of bodies, etc.—which contain procedural steps or processes within the administrative procedure itself.*
2. *Not relevant are all pieces of legislation that not contain above-mentioned elements.*

It should also be emphasised that all legal and sub-legal acts have been reviewed, commented on, or drafted in a way that at the very least promotes digitalisation, if not fully regulates it. For this purpose, the methodology integrated into the Programme has been used, specifically sections “1.4 Elements” and “1.5 General Methodology for Preventing and Reducing the Administrative Burden”, which has been applied throughout the process and has been updated to become Annex 2 of the new Programme 2025–2028. This list has combined the principles of general administrative procedure with those of electronic governance.

Therefore, the OPM (Office of the Prime Minister) has commented on and supported the drafting of legal and sub-legal acts only in terms of the design of procedures and services and the promotion of digitalisation, and not with regard to legality and constitutionality, which remain the responsibility of the legal departments.

Primary legal acts

The OPM has provided comments on all laws that were submitted for review and feedback during the preliminary consultation phase and, in some cases, has also held meetings with the institutions responsible for the laws, where the draft laws were relevant to administrative burden. When draft laws were not relevant to administrative burden, no action was taken towards the ministries, but the matter was recorded and filed in the administrative burden dossier.

However, it should be emphasised that the process of preventing administrative burden only began in the second half of June 2023. By that time, a significant number of laws had already been approved by the Government and submitted to the Assembly, and these were passed without undergoing administrative burden prevention checks, as the process had not yet commenced.

That said, in 2024 the review of laws for administrative burden prevention has become systematic. With the exception of two laws, all laws approved by the Government have been reviewed for this purpose. These two laws had been drafted well before the current process began.

It should be noted that in 2024, the majority of laws approved by the Government were not relevant to administrative burden. Nonetheless, throughout 2024, the OPM has reviewed 19 draft laws that are still in process and not yet approved—eight of which are relevant to administrative burden, and two of which are being fully supported in their drafting as part of this process.

As shown in the table, in 2023, seven laws were reviewed for the purpose of preventing administrative burden. All of them were approved by the Government, while three were also approved by the Assembly. Of the seven laws approved by the Government, four were relevant to administrative burden and were commented on in the necessary provisions. A total of 40 comments were submitted, 15 of which were addressed. As a result, five services have been simplified. However, it should be noted that three of these are still awaiting approval by the Assembly for the simplification to become final.

As shown in the table, in 2024, a total of 51 laws were approved by the Government, 15 of which were also approved by the Assembly. Out of the 51 laws approved by the Government, 49 were reviewed for the purpose of preventing administrative burden. The two laws that were not reviewed for this purpose are relevant to administrative burden; however, their drafting took place much earlier, and public consultations for them were concluded in January 2022—around a year and a half before the process began. Of the 49 laws reviewed, three were relevant to administrative burden. For these, 75 necessary comments were provided on the legal provisions, 32 of which were addressed by the institutions. This led to the prevention and simplification of six services. It should be emphasised that all of these still await approval by the Assembly in order for the simplification to become final.

The ABR indicator in the Kosovo Reform Agenda (Growth Plan)⁸

Within the framework of the Kosovo Reform Agenda, also known as the Growth Plan, the Government of Kosovo has negotiated Indicator 2.1.1.1: *100% of the new laws imposing an administrative burden are reviewed in context of prevention of administrative burden according to Administrative Burden Reduction methodology*. The deadline for achieving this indicator is 30 June 2025; however, this report presents results up to 31 December 2024. The Growth Plan was approved on 9 October 2024.

Therefore, the measurement of the indicator has been conducted from the first Government meeting held after 9 October onwards, by officials of the Strategic Planning Office.

For this purpose, the table below presents results only for those laws approved from 23 October onwards—when the first meeting following the approval of the Reform Agenda took place—up to 31 December 2024

Thus, the records in this table and in Annex 4 demonstrate that the indicator has been fully achieved (100%). The annex also includes the dates of approvals, decision numbers, publication links, and other information, to ensure that the documentation is easily traceable. This is particularly important as the link on the OPM website for laws approved in 2024 provides only the titles of the approved laws and their respective ministries, without further details.⁹

Throughout 2024, an additional 19 draft laws have been reviewed, which are still in process and have not yet been approved by the Government. Of the 19 reviewed, 8 are relevant to administrative burden, and 138 necessary comments have been provided on the respective legal provisions. Further measurements will be conducted once these laws are approved by the Government and the Assembly.

It should be noted that this does not include two laws which have not been commented on, but are being drafted exclusively for the purpose of administrative burden. In these cases, we may consider that there is 100% addressing.

Secondary legal acts¹¹

As with legal acts, the process for sub-legal acts also began in the second half of 2023. It should be noted that sub-legal acts are greater in number than legal acts, tend to contain more administrative burden, and are more difficult to keep under constant oversight due to the high volume and fast-paced nature of drafting work throughout the year.

For this reason, the Strategic Planning Office has reviewed sub-legal acts that were submitted during the preliminary consultation, public consultation, and in some cases even during the drafting phase, starting from the second half of 2023. A number of sub-legal acts were approved during the second half of 2023; however, they had been drafted or had undergone consultation in the first half of 2023 or earlier. Therefore, they were not subject to the administrative burden prevention and reduction review.

As shown in the table below, a total of 160 sub-legal acts were reviewed during 2023 and 2024—45 in 2023 and 125 in 2024. Of these, 57 were relevant to administrative burden (AB), while 113 were not. Among the 57 relevant acts, 20 were drafted by the AB team with the specific aim of preventing and reducing administrative burden, of which 10 were approved in 2024. For the 37 AB-relevant sub-legal acts that were commented on, 175 comments were provided, of which 29 were addressed. As a result of these addressed comments and the sub-legal acts drafted specifically for AB, a total of 66 services were simplified.

It should also be emphasised that 78 sub-legal acts are currently in process and are expected to be approved during 2025. For these sub-legal acts in progress, 215 comments have already been submitted, and it is anticipated that more than 50 additional services will be simplified as a result.

Reduction

The reduction of administrative burden has been focused at both the central and local levels, encompassing the preparatory and operational phases for the simplification and digitalisation of services. Preparation for the simplification and digitalisation of services includes the analysis of legislation and the regulatory framework, along with the proposal of necessary recommendations for intervention. It also involves analysing the current state of the digital framework and how it should be developed, using the “As Is, To Be” methodology.

Below is a summary of the main work processes carried out during the period 2022–2024, for which a considerable number of activities have been undertaken.

Simplification of services in central level

The reduction of administrative burden has been focused at both the central and local levels, encompassing both the preparatory and operational phases for the simplification and digitalisation of services. Preparation for the simplification and digitalisation of services includes analysing the legislation and regulatory framework, and proposing the necessary recommendations for intervention. It also involves assessing the current state of the digital framework and how it should be developed, using the “As Is, To Be” method.

Below is a summary of the main work processes carried out during the period 2022–2024, for which a significant number of activities have been undertaken.¹²

1. *Development of the central-level service catalogue*
2. *Needs and experience analysis of taxpayers regarding communication and services provided by the Tax Administration of Kosovo (TAK)*
3. *Development of a methodology for services that can be provided digitally without the need for an electronic signature*
4. *Development of a concept for updating and modernising client services at TAK*
5. *Analysis for simplifying permits issued by independent bodies: AAC, IMC, ERO, CBK, KIA, ICMM, ARKEP, and RRA*
6. *Development of a Public Information Guide on Inspections*
7. *Development of three (3) Inspection Guides:*
 - a. *On mandatory data requirements for recording inspections and reporting at various levels within the inspectorate system*
 - b. *Updating checklists*
 - c. *Joint inspections*
8. *Development of an analysis on the impact of regulatory inspections on Kosovar businesses*
9. *Development of a guide for designing and implementing complaints mechanisms for third-party requests and inspection appeals, aimed at promoting third-party initiated inspections*
10. *Detailed legal and procedural analysis using the “AS IS, TO BE” method for construction permits of categories 1, 2, and 3*
11. *Technical specifications for the full digitalisation of construction permits for categories 1, 2, and 3*

12. *Concept for simplifying the ID card issuance service for citizens of Kosovo*
13. *Analysis of the application of the EU Services Directive for legal services and services related to driving licences*
14. *Analysis of the current regulatory status of the Chamber of Architects and Engineers (CAE) in the field of construction*
15. *Development of a legal analysis for integrating POS systems into service provision*
16. *Analysis of 100 permits and licences for potential removal of re-licensing, based on risk and inspectorate capacities.*

Simplification of services in local level

Regarding the simplification of municipal services, it should be emphasised that interventions are more limited due to the municipalities' own competencies, as well as the generally low willingness for change—both at the municipal level and at the central level where the latter may have some influence. For this reason, an administrative burden indicator has been included in the Municipal Performance Grant, in order to encourage simplification at the local level. This has been remarkably successful, resulting in the simplification of over 400 services across 20 municipalities within an exceptionally short period of time.

Therefore, below we present some of the main processes and a table outlining the simplification efforts in all municipalities.

1. *Preparation of the concept and methodology for the simplification of services in municipalities*
2. *Development of the local-level service catalogue*

For all of these services—whether developed or in development—several criteria have been followed, including: analysis of frequency and population coverage, legal analysis and amendments where necessary, creation of a digital prototype, testing and consultation with stakeholders or user involvement, testing with officials, training of officials for usage, and publication on the eKosova platform.

5 Collaboration

Collaboration with third parties in the implementation of the Programme is one of the key aspects for achieving results. In this regard, the Strategic Planning Office (SPO) has expanded its cooperation for the implementation of the Programme with various development partners, civil society organisations, business chambers, and strategic foreign partners in the field.

With respect to collaboration with civil society, the new approach of the Programme shifted the focus from advocacy for implementation to participation in the implementation of the Programme itself.

In terms of cooperation with business chambers, the new approach redirected collaboration towards greater involvement of their members in the design of public policies, through the implementation of the principle of personalisation and the co-design methodology.

As for cooperation with strategic foreign partners—such as the OECD/SIGMA, the e-Governance Academy, etc.—partnership has been enhanced through their engagement not only in advisory roles but also in the implementation of various activities, such as the Digital Camps, the regional conference on administrative burden, and other activities focused on strategic guidance and consultation.
