**REGULATION (OPM) NO. 06/2026 ON THE INTERNAL
ORGANIZATION AND SYSTEMATIZATION OF JOBS IN THE
CENTRAL INSPECTORATE OF MARKET SURVEILLANCE¹**

Prime Minister of the Republic of Kosovo,

Pursuant to Article 94 (paragraph 3) of the Constitution of the Republic of Kosovo, Article 28 paragraph 3 of Law No. 06/L-113 on the Organization and Functioning of the State Administration and Independent Agencies of the Republic of Kosovo, Article 15 of Law No. 08/L-279 on Central Inspectorate of Market Surveillance, and Article 9 paragraph 7 of Regulation (GRK) No. 01/2020 on Standards of Internal Organization, Job Systematization and Cooperation in State Administration Institutions and Independent Agencies,

**REGULATION (OPM) NO. 06/2026 ON THE INTERNAL ORGANIZATION AND
SYSTEMATIZATION OF JOBS IN THE CENTRAL INSPECTORATE OF
MARKET SURVEILLANCE**

**Article 1
Purpose**

This Regulation aims to determine the organization and systematization of job positions in the Central Inspectorate of Market Surveillance, within the Ministry of Industry, Entrepreneurship and Trade (hereinafter: CIMS).

**Article 2
Scope**

This Regulation shall apply to the Central Inspectorate of Market Surveillance. The general principles and procedures of the Central Inspectorate of Market Surveillance are determined by the Law on Inspections, and the general competencies by the relevant law of the Central Inspectorate of Market Surveillance.

**Article 3
Mission**

CIMS is an executive agency under the Ministry of Industry, Entrepreneurship and Trade established by law, which is responsible for supervising the implementation of the relevant legislation in force in the field of inspections and market surveillance, in the field of consumer protection, in the field of trading in oil and oil derivatives, in the field of product safety and conformity assessment, in the field of precious metals, trademarks, in the field of internal trade and services, in the field of tourism, in the field of copyright and related rights, in the field of production, collection, processing and trade of tobacco, in the field of construction products, in the field of protection of fair competition, combating informality and unfair trade practices, cooperates with various institutions, conducts product risk assessments on a regular basis and drafts the inspection plan to ensure the safety of all goods and services circulating in the internal market of the Republic of Kosovo.

Article 4

Organizational structure of the Central Inspectorate of Market Surveillance

1. The functional or organizational structure of the Central Inspectorate of Market Surveillance is as follows:
 - 1.1. Office of the Chief Inspector;
 - 1.2. Inspection Division and
 - 1.3. Administrative Affairs Division.
2. The duties and responsibilities of the Chief Inspector are determined by the relevant Law on the Organization and Functioning of State Administration and Independent Agencies.
3. The duties and responsibilities of the civil servant of the Office of the Chief Inspector are determined by the relevant Law on Public Officials.
4. The number of employees in the Central Inspectorate of Market Surveillance is forty-eight (48).

Article 5

Office of the Chief Inspector

1. The Office of the Chief Inspector of the Central Inspectorate of Market Surveillance consists of:
 - 1.1. Chief Inspector;
 - 1.2. Administrative assistant
2. The number of employees in the Office of the Chief Inspector is two (2) civil servants.

Article 6

Inspections Division

1. The mission of the Inspection Division is to supervise the implementation of the relevant legislation in force in the field of inspections and market surveillance, in the field of consumer protection, in the field of trading in oil and oil derivatives, in the field of product safety and conformity assessment, in the field of precious metals, in the field of trademarks, in the field of internal trade and services, in the field of tourism, in the field of copyright and related rights, in the field of production, collection, processing and trade of Tobacco, in the field of Construction Products, in the field of protection of fair competition, in the fight against informality and unfair trade practices, in cooperation with various institutions, in the assessment of the risks of products on a regular basis and in the drafting of an inspection plan to ensure the safety of all goods and services circulating in the internal market of the Republic of Kosovo.

2. The duties and responsibilities of the Inspections Division are as follows:

- 2.1. Supervise and implement the relevant legislation in force in the field of inspections and market surveillance;

- 2.2. Supervise and implement the relevant legislation in force in the field of consumer protection;
- 2.3. Supervise the implementation of legislation and technical procedures in the field of trading in oil and oil derivatives;
- 2.4. Supervise the implementation of legislation and technical procedures in the field of product safety and conformity assessment;
- 2.5. Supervise the implementation of legislation and technical procedures in the field of precious metals;
- 2.6. Supervise the implementation of legislation and technical procedures in the field of trademarks;
- 2.7 Supervise and implement the relevant legislation in force in the field of internal trade and services;
- 2.8. Supervise and implement the relevant legislation in force in the field of tourism;
- 2.9. Supervise and implement the relevant legislation in force in the field of copyright and related rights;
- 2.10. Supervise and implement the relevant legislation in force in the field of tobacco production, collection, processing and trade;
- 2.11. Supervise and implement the relevant legislation in force in the field of construction products;
- 2.12. Undertakes inspection actions to protect consumer rights;
- 2.13. Coordinate activities and cooperate with other bodies responsible for supervising the implementation of the relevant legislation in force;
- 2.14. Take action to protect fair competition, combat informality and unfair trade practices;
- 2.15. Cooperate with the Kosovo Metrology Agency for the verification of the declared composition of food and non-food products as well as liquid petroleum fuels;
- 2.16. Cooperate with Kosovo Customs according to risk assessment models;
- 2.17. Coordinate activities and cooperate with other relevant institutions and laboratories for testing and verifying product safety;
- 2.18. Conduct product risk assessments on a regular basis and draft a plan for their inspection;
- 2.19. Ensure the safety of all goods and services circulating in the internal market of the Republic of Kosovo;

- 2.20. Based on the publication of products in the RAPEX system, remove dangerous products encountered in the domestic market of the Republic of Kosovo;
- 2.21. Undertake punitive measures for violations found in accordance with applicable legislation;
3. The Head of the Inspections Division shall report to the Chief Inspector.
4. The number of employees in this Division is forty-one (41).

Article 7 **Administrative Affairs Division**

1. The mission of the Administrative Affairs Division is to provide professional support to officials of the Central Inspectorate of Market Surveillance to guarantee the implementation of the laws over which the Central Inspectorate of Market Surveillance has supervisory competence.
2. Duties and responsibilities of the Administrative Affairs Division are as follows:
 - 2.1. Provide legal and organizational assistance to all organizational structures of the Central Inspectorate of Market Surveillance;
 - 2.2. Provide legal support in handling cases addressed to the Central Inspectorate of Market Surveillance and draft relevant decisions and other legal documents in accordance with the applicable legislation;
 - 2.3. Draft legal acts in accordance with inspection records;
 - 2.4. Provide legal assistance in the drafting and development of market surveillance procedures;
 - 2.5. Management, realization, reconciliation and reporting of CIMS revenues;
3. The Head of the Administrative Affairs Division shall report to the Chief Inspector.
4. The number of employees in the Administrative Affairs Division is five (5).

Article 8 **General Services**

The Ministry of Industry, Entrepreneurship and Trade is obligated to provide general services to CIMS according to the legislation in force.

Article 9
Abrogation

Entry into force of this Regulation shall repeal Regulation No. 10/2013 on the Internal Organization and Systematization of Jobs in the Market Inspectorate.

Article 10
Entry into force

This regulation shall enter into force seven (7) days after its publication in the Official Gazette of the Republic of Kosovo.
