Pursuant to Article 92, paragraph 4, and Article 93, paragraph 4, of the Constitution of the Republic of Kosovo, Article 8 of Law No. 08/L-117 on the Government of the Republic of Kosovo, and Article 3 of Law No. 03/L-183 on the Implementation of International Sanctions, in accordance with Articles 65 and 78 of Regulation No. 17/2024 on the Work of the Government of the Republic of Kosovo, the acting Government of the Republic of Kosovo, at the meeting held on 5 May 2026, hereby adopts the following:

**DECISION**

**On the amendment of Government Decision No. 01/64 of 25.02.2022 on the implementation of international sanctions “with the aim of aligning the foreign policy of the Republic of Kosovo with the Common Foreign and Security Policy (CFSP) of the European Union”**

1. Point 1 of Government Decision No. 01/64, dated 25.02.2022, is supplemented as follows: The Government of the Republic of Kosovo implements the sanctions imposed by the Council of the European Union through:

2. All types of sanctions, as well as the names of individuals, entities and products sanctioned through the decisions and the legal acts of the Council of the European Union, and the respective annexes referred to in point 1, are considered an integral part of this decision.
3. The restrictive measures will remain in force until a further decision and, depending on the circumstances, may be updated, supplemented, or amended.
4. The responsible institutions are obliged to implement this decision, in accordance with the legislation in force.
5. This Decision will enter into force on the day of its publication in the Official Gazette of the Republic of Kosovo.
