The Prime Minister of the Republic of Kosovo,

Pursuant to Article 94 (3) of the Constitution of the Republic of Kosovo, Article 28 (3) of Law No. 06/L-113 on the Organization and Functioning of the State Administration and Independent Agencies, Article 4 (2) of Law No. 08/L-279 on the Central Market Surveillance Inspectorate, Article 9 (1.11) of Law No. 08/L-117 on the Government of the Republic of Kosovo, and Article 9 (7) of Regulation (GRK) No. 01/2020 on Standards of Internal Organization, Systematization of Jobs and Cooperation in State Administration Institutions and Independent Agencies, issues the following:

REGULATION (OPM) NO. 12/2026 ON AMENDING AND SUPPLEMENTING REGULATION (OPM) NO. 06/2026 ON THE INTERNAL ORGANIZATION AND SYSTEMATIZATION OF JOBS IN THE CENTRAL MARKET SURVEILLANCE INSPECTORATE

Article 1 Purpose

The purpose of this Regulation shall be to amend and supplement Regulation (OPM) No. 06/2026 on the Internal Organization and Systematization of Jobs in the Central Market Surveillance Inspectorate.

Article 2

Paragraph 4 of Article 4 of the basic Regulation shall be amended and supplemented with the following text:

The number of employees in the Central Market Surveillance Inspectorate shall be one hundred and ten (110) civil servants.

Article 3

Paragraph 4 of Article 6 of the basic Regulation shall be amended and supplemented with the following text:

4. The number of civil servants in this Division shall be one hundred and three (103) civil servants.

Article 4
Entry into Force

This Regulation shall enter into force seven (7) days following its publication in the Official Gazette of the Republic of Kosovo.
