Pursuant to Article 92, paragraph 4, and Article 93, paragraph 4, of the Constitution of the Republic of Kosovo; Article 8 of Law No. 08/L-117 on the Government of the Republic of Kosovo; Article 3 of Law No. 03/L-183 on the Implementation of International Sanctions; and in accordance with Articles 65 and 78 of the Rules of Procedure of the Government of the Republic of Kosovo No. 17/2024, the Acting Government of the Republic of Kosovo, in its meeting held on 1 September 2026, adopts the following:

D E C I S I O N

On the amendment and supplementation of Government Decision No. 01/64, dated 25.02.2022, on the implementation of international sanctions for the purpose of aligning the foreign policy of the Republic of Kosovo with the Common Foreign and Security Policy (CFSP) of the European Union

1. Point 1 of Government Decision No. 01/64, dated 25.02.2022, shall be supplemented as follows, the Government of the Republic of Kosovo shall implement the sanctions imposed by the Council of the European Union through:

 - 1.27. Council Decision (CFSP) 2026/1849 of 23 July 2026 amending Decision 2014/512/CFSP concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine;
2. All types of sanctions, the names of sanctioned individuals and entities, as well as the goods and products specified and listed in the relevant acts of the Council of the European Union pursuant to point 1 of this Decision, including annexes and any amendments, supplements, or repeals thereof, shall be considered an integral part of this Decision. The restrictive measures shall remain in force until another decision is adopted and, depending on circumstances, may be updated, supplemented, or amended.
 3. The institutions responsible for the implementation of this Decision are hereby obliged to act in accordance with the applicable legislation.
 4. This Decision shall enter into force on the day of its publication in the Official Gazette of the Republic of Kosovo.
